- Your missionaries can count on your regular participation in their ministries.
- Electronic donations save the Mission time and money.

### **How Do You Sign Up?**

- Decide what amount you wish to donate each month and which bank account you want to use.
- Complete the Authorization Agreement Form. Be sure to sign and date it in the area provided.
- Designate which missionaries or funds you wish to support each month. Include the amount for each and the total amount to be debited from your bank account.
- Mail the Authorization Agreement Form to Fellowship International Mission along with a voided blank check (for a checking account) or a deposit slip (for a savings account.)

## **How Will FIM Respond?**

- Fellowship International Mission will make the necessary arrangements with your bank to begin the transactions.
- Transfers will begin the month after the Mission has received the Authorization Agreement Form.
- Transfers normally occur on or before the tenth of each month.
- We will send you an appropriate acknowledgement for your gift.

# How Do You Make a Change?

- If you desire to increase your donation amount, change the designation of any gift, or change the designated bank account, please submit a new Authorization Form. This form is available from our home office or from our website at fim.org.
- The authorization to charge your account will remain in effect until you cancel the agreement by notifying FIM in writing.
